Linda Fabiani outlined Group activity over the last year:

The Group had 38 Subscribing Member in the 2013/14 Year

A Landscape Charter for Scotland (17 September 2013) – 42 people attended (3 MSPs)

Based on the discussion at the meeting Linda sent a letter to Fiona Hyslop, Cabinet Secretary for Culture and External Affairs highlighting four specific aspects for consideration (24 Dec 2013) and we have recently received a reply (24 April 2014) from Paul Wheelhouse MSP Minister for Environment and Climate Change which has been passed to the Landscape institute for consideration.

Sustainability in the Scottish Construction Industry (27 November 2013) – 31 people attended (1 MSP)

Are Scotland's Places the Best Place in the World to grow up? (25 February 2014) - 46 people attended (1 MSP)

Members of the CPG on Children and Young People were invited to this meeting

The young people from Forfar were very inspired by the evening in the parliament and with the help of Space Unlimited they ran a Crowdfunding Campaign and have raised £4,500 to run an exhibition on their project.

It was agreed that we should try and involve young people in meetings more often.

Scotland has a Historic Environment Strategy – so what next? (29 April 2014) – 50 people attended (3 MSPs)

It was noted that there will be a debate in the chamber during w/c 16 June of this topic and the Key Points of the meeting along with additional information provided by BEFS will be circulated to MSPs prior to the debate.
