13/06/2018 – The meeting was addressed by Deputy First Minister on the subject of whether Scotland should commission an ACE-study, similar to that carried out in Wales and England, to establish a baseline for ACE's in Scotland. The meeting also considered the value of promoting adoption of Trauma-informed schools in Scotland. The meeting also had a discussion on future topics.

MSP Attendees – Gail Ross MSP (Chair), John Swinney MSP, Elaine Smith MSP, Rona Mackay MSP, Mari Gougeon MSP, Liam Kerr MSP, Liam McArthur MSP, Emma Harper MSP, Jenny Gilruth MSP.

There were 22 other attendees at the meeting.

27/09/2018 – This meeting heard presentations from Bailey-Lee Robb MSYP on the work of the Youth Parliament in relation to ACE's and he outlined a recent motion passed by the Youth Parliament on raising awareness of ACE's.

This was followed by Callum Lynch, Public Affairs Officer at Who Cares? Scotland who detailed his own experiences of the care system and the impace of ACE's on his own life.

This meeting also included a screening of the short film, 'Be That Person' produced by Fife Council to provide better support to children with the issue of ACE's repeatedly addressed in the film.

There then followed a question and discussion session among those attending, and a discussion on Trauma informed schools.

There were 23 other attendees.

21/11/2018 – The focus for this meeting was Trauma-informed communities.

The Group heard from George Hosking from WAVE Trust on the creation of a number of pilot trauma-informed communities across the UK, including 4 in Scotland.

This was followed by a presentation from Cllr Elspeth Kerr from Glasgow City Council who outlined the experiences of the community in Drumchapel/Anniesland which is one of the Scottish pilot areas.

The meeting then heard from Suzie Scott from the Glasgow Council for the Voluntary Sector who discussed the work of the GCVA and it's role as a link between public sector and third sector in the city in tackling poverty levels and the wide attainment gap.

The final speaker at this meeting was Julia Morton from The Haven in Stonehaven who described her journey from delivering yoga in prisons to realising then need to help earlier in their lives which led to delivering yoga for children and pregnant mums. 'The Haven' has been set up as a centre for healing, and is the core of the trauma-informed community initiative in Stonehaven.

There then followed an open discussion on the topics presented.

There were 19 other attendees at the meeting.

27/03/2019 – The group heard from speakers on the topic - ACE's and Mental Health.

Professor Thanos Karatzias, Professor of Mental Health at Edinburgh Napier University outlined research on ACE prevalence in different populations and compared the impact of adult trauma versus childhood trauma

Susan McKellar, Parenting Network Scotland, described the work Parent Network Scotland are carrying out with parents who have challenging children, using the ACE recovery toolkit of Rockpool.

Sally Amor, Child Health Commissioner and Public Health Specialist, described the 2018 Annual report of the Director of Public Health for NHS Highland – 'Adverse Childhood Experiences, Resiliance and Trauma Informed care: A public health approach to understanding and responding to adversity'

Helen Minnis, Professor of Child and Adolescent Psychology at the University of Glasgow, outlined some of the evidence from a meeting to discuss NICE guidelines on attachment and spoke of Reactive Attachment Disorder. She then went on to outlined the ESSENCE concept in which early symptoms of problems elicit attention to neurodevelopmental issues.

There then followed an open discussion on the topics covered.
