- 1) Name and Purpose of the Group

**It was agreed that** the group should be called the Cross party Group on Social Science and the following was agreed as a statement of the groups aims:

*The Group will provide a forum to draw together social science research on policy topics of interest to MSPs. Doing so will further broaden the evidence base for debate of contemporary issues and the scrutiny of legislation. In addition it will help strengthen the relationships between parliamentarians and academics, encouraging interaction beyond those subjects specifically discussed by the group.*

*The public has an interest both in improving the evidence base available to policymakers but also in ensuring that publically-funded research is put to use for the public good.*

*The group will agree policy areas of particular interest at any given time and then identify, through the secretariat or other means, researchers currently investigating those issues. As a result it is quite likely that there will be overlap with other CPGs in terms of the content of discussion but that this Group will frequently take a different approach. As a result, joint meetings with other CPGs are not only anticipated but enthusiastically awaited.*

*Possible topics for discussion include homelessness, education, 'What is productivity', budgetary scrutiny, the impact of robots in the workplace on policymaking, detailed analysis of who actually makes up Scotland's workforce, what can domestic policymaking learn from the experience of international development, how can sustainable development goals be applied across the policymaking agenda, what would a rights-based approach to policymaking look like, the current health of social science in Scotland.*

- 2) **Election of Convenor**
