1. Welcome

Margaret McCulloch MSP as Co-Convenor opened the meeting and welcomed members.

2. Apologies & matters arising

Ms McCulloch noted that there were a number of apologies from Members. There were no matters arising from the previous minutes

3. Presentations

Rebecca Chad and Laura Peacock presented on Education-led Skills Development and Employer-led Skills Development respectively.

Rebecca provided an overview of Education Scotland's role and activity in undertaking Developing the Young Workforce (DYW), including developing a Standard for Career Education and Work Placements while Laura explained how Investors In Young People (IIYP) is working with employers to encourage them to recruit and develop young people.

The main message was that collaboration and partnership working is vital to the success of DYW and providing the broadest range of opportunities for young people.

Stephen Young from the Civil Engineering Contractors Association reported that it was difficult to get young people into construction and engineering. Laura Peacock commented that for IIYP this was an area with the most uptake, however there was a need for more role models and employers going into schools so that young people find out more about the opportunities that exist.

Kate Sankey from Loch Lomond & Trossachs Community Partnership requested that rural areas are also considered on these initiatives. Rebecca Chad reported that there will now be more DYW regional groups and that the Highlands and Island would have several.

A question was asked on what is being done to attract more women and BME groups into apprenticeships and employment. Laura Peacock reported that other organisations such as Skills Development Scotland were leading on this area however IIYP were encouraging employers to widen the pool of talent and ensure that recruitment processes were not a hindrance.
