MINUTES OF PREVIOUS MEETINGS

1. The SPCB agreed the minute of the previous meeting held on 26 March 2014.

MATTERS ARISING

Smoking Policy: e-cigarettes

2. After careful consideration, the SPCB agreed that e-cigarettes would be subject to the same restrictions as smoking in the Scottish Parliament. The SPCB's decision to treat e-cigarettes in this way was based on a precautionary approach and is in line with advice issued to all Scottish NHS health boards by the Scottish Directors of Public Health. The SPCB's smoke free policy would be amended to reflect this change and building users advised.

Referendum

3. The SPCB noted an update on planning to facilitate the anticipated media presence at Holyrood on the day of the Referendum.

Security pass

4. The SPCB declined a request for a Former Member pass.
